1. A membership list of all our affiliates is published in the Homes/Lifestyles publications for both Marshall and Fulton County. The publications are distributed throughout both counties at various business locations in their respective counties
2. Becoming an Affiliate Member also gives you the opportunity to place an ad in the Homes/Lifestyles publications for both counties.
3. Our Board meetings are held as scheduled on the third Wednesday of the month. Other meetings are announced with the time and location by e-mail or by our monthly newsletter, which each affiliate receives. Meeting notices are sent to all affiliates advising them of the time location and program for the month by e-mail (if available) or by regular mail if not available.
4. Throughout the year we offer Continuing Education for our members and Orientation for new members with many of our Affiliate sponsoring the programs and participating in course presentation. We also conduct a Golf Outing in September, Affiliate Fair which is usually planned for April or May and the annual Christmas Party in December. We encourage Affiliates to participate in these events to promote their business.
